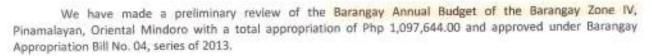

- b. Priority in the use of income shall be for budgetary requirements as mandated by local code.
 - -20% of IRA for development Projects
 - -5% for unforseen events
 - -5% for Gender and Advocacy
 - -10% for Sangguniang Kabataan
 - -2% Discretionary Fund
- c. Strict compliance to the 55% Persponal Services limitation shall be observed.
- d. Priority in the use of savings shall be for basic services, augmentation of development projects and other mandatory expenses provided under the Local Code.
- e. All procurement shall follow strictly the provision of R.A. 9184.

Section 5.EFFECTIVITY. This Ordinance shall take effect on January 01,2014.

AN ORDINANCE APPROVING PHILHEALTH INSURANCE OF SANGGUNIANG BARANGAY OFFICIALS AND STAFFS AND AUTHORIZING THE BARANGAY CHAIRMAN, DANILO I. DAEL, TO ENTER INTO A CONTRACT WITH SAID PHILHEALTH INSURANCE, FOR THE PURPOSE OF ACQUIRING A PROGRAM WITH INSURANCE COVERAGE FOR THE OFFICIALS AND STAFFS OF BARANGAY ZONE IV

WHEREAS, as per Section 393, Paragraph b, Sub-paragraph 2 of the benefits of Barangay Officials of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that — "(b) The Punong Barangay, the Sangguniang Barangay members, the Barangay Secretary and the Barangay Treasurer shall also be entitled during their incumbency, to incurance which shall include but not be limited to temporary and permanent disability, double indemnity, accidence insurance, death and burials benefits"

WHEREAS, in order to realize said provision, as well as to enhance the welfare of the officials and staffs of the barangay, there is a need to authorize the Barangay Chairman to enter into contract with the PHILHEALTH INSURANCE to recognized and reputable company, for the purpose of insurance coverage of the Barangay Officials and Staffs.

NOW THEREFORE, on motion of Barangay Kagawad, HON. GUADALUPE M. JALOTJOT, seconded by Barangay Kagawad, HON. NIMFA M. RAAGAS, be it —

RESOLVED as it is hereby RESOLVED to approve as it is hereby APPROVING PHILHEALTH INSURANCE COVERAGE for the benefits of officials and staffs of Barangay Zone IV, Pinamalayan, Oriental Mindoro.

RESOLVED FURTHER as it is hereby FURTHER RESOLVED to authorize the Barangay Treasurer, MINDA PANGANIBAN, to withdraw from the bank the amount necessary for the payment of premium of said Philhealth Insurance;
